# Communities and Justice Core Client Outcome and Indicator Bank

The Department of Communities and Justice (DCJ) has developed a Core Client Outcome and Indicator Bank. This will support us to identify and use outcomes and indicators that are relevant to our work.


This document explains what the core client outcome and indicator bank is, why it was developed and how it can be used. It then lists the core client outcomes and indicators developed for use by DCJ. It contains preliminary analysis and identification of relevant existing data sources that may be used to measure client outcomes; existing measures and counting rules and information about whether the data may be available for DCJ specific population groups.

# What is the Communities and Justice Core Client Outcome and Indicator Bank?

The Core Client Outcome and Indicator Bank (Indicator Bank) is a catalogue of identified client outcomes and indicators. It contains:

- the full list of core client outcomes and indicators
- preliminary analysis of identified data sources

The Indicator Bank consists of 37 outcomes that are relevant, but not exclusive to all DCJ clients.



They are outcomes that are crucial to client wellbeing. The Indicator Bank includes 116 indicators to measure these outcomes. These outcomes and indicators have been mapped to the NSW Human Services Outcomes Framework.

The Indicator Bank is not an exhaustive list of client outcomes and indicators. It will be updated and revised as new information, evidence and data becomes available.

# Why was the Core Client Outcome and Indicator Bank developed?

The Indicator Bank was developed to support DCJ to measure client outcomes.

Measuring client outcomes enables us to better understand and meet the needs of clients. It provides important information about the quality of our programs, so we can improve our services and ensure they make a long-term positive difference in our client's lives. It also

supports us to build the evidence base for our programs, so we can do more of what works and less of what doesn't.

#### How will the Core Client Outcome and Indicator Bank be used?

The Indicator Bank supports DCJ to identify, measure and commission for client outcomes.

The Indicator Bank could be used to identify long-term client outcomes that a program or service is trying to achieve. All 37 core client outcomes are listed in the bank. You can sort the outcomes by domains: Home, Safety, Education & Skills, Economic, Health, Social & Community and Empowerment.

Once you have identified the outcomes relevant to your work, you can use the bank to identify relevant indicators to measure client outcomes. There are 116 indicators in total. Each outcome has at least one indicator to choose from.

We can use these indicators to consistently monitor the impact of our services and programs. We can use this information to inform discussions about future service delivery i.e. how we deliver services, what services should be prioritised and what services need to be adapted to achieve better outcomes.

#### What are the data gaps?

A full set of data is required to understand client outcomes and how they were achieved. Indicators, measures and data have been identified to track each core client outcome. These are provided below in our Indicator Bank.

There are currently gaps in the availability of outcome data. Our data gap analysis showed that only 25 of the indicators (22%) have data available within DCJ for at least one client group; 16 further indicators (14%) have data available from other agencies through data linkage. More than half of the indicators have no existing data source identified and new data are required.

In addition to client outcome information, to fully understand the impact of our services on clients, robust data needs to be collected on client needs and risks, the services they receive, costs and efficiency, and client experience.

#### What's next?

#### **Tracking core client outcomes**

Additional work is being conducted to identify the information, evidence and data that is needed to track the core client outcomes. Some of this data is already available to DCJ (e.g. child protection data, housing data). However, some of this data needs to be obtained by data linkage with other government departments (e.g. education and health data).

In addition, research and evidence development needs to be undertaken to create appropriate measures for new outcome indicators.		

### How to read the Indicator Bank

The Core Client Outcome and Indicator Bank is broken up into the seven domains of the NSW Human Services Outcomes Framework: Safety, Home, Social & Community, Empowerment, Health, Education & Skills and Economic.

Under each domain is listed the relevant core client outcomes and their corresponding indicators. Where we have been able to, preliminary analysis of identified data sources is provided including existing measures and counting rules and information about whether the data may be available for DCJ specific population groups. Below is an example of how each of the core client outcomes and indicators are presented.
