or, if the original application related to incomplete overseas studies not leading to an overseas law qualification or to incomplete or unaccredited Australian studies:

### **PART F: Submitting your application**

#### Filling in the application

You can fill in the application electronically and print it out to sign. Or you can print it and fill it in by handwriting.

#### Attach all the required documentation

Please ensure you attach all the required documentation (Part C). Your application cannot be processed if any of your documentation is missing. Note:

- Where an **original** document is required, only an original will be accepted. Notarised or certified copies are not an acceptable substitute where an original is required.
- Original transcripts of your academic record will be retained permanently in the Board's office and you will not need to provide this transcript at the time you apply for admission.
- If you are unable to provide original transcripts of your academic record, please contact the Office of the Board before submitting your application. Failure to provide original transcripts is likely to result in a delay in the assessment of your qualifications, due to the need to agree on and obtain verification from other sources.

#### Submit your application with your fee

After you complete the application, you need to scan the material (including the copy of the receipt for payment of the prescribed fee) into a single PDF digital file and email the PDF file to <a href="mailto:lpab@justice.nsw.gov.au">lpab@justice.nsw.gov.au</a>.

Do not email the PDF if any evidence or details are missing, and do not email multiple separate PDFs. All your documentary evidence must be included in a single PDF file.

After you email your PDF, you must also forward the original application, including original academic transcripts, and other supporting documents by post to the Office of the LPAB at GPO Box 3980 Sydney NSW 2001.

Once your email application has been received, the Office of the LPAB will check your application and advise you if anything is not in order or if you need to provide any additional information to support your application.

If you are required to post the originals of your academic transcripts (or any other documentary evidence) to us, your application cannot be determined, until after we have received and assessed all the requested originals.
