# NSW Admission Board Amendment (Fees) Rule 2025

under the

Legal Profession Uniform Law Application Act 2014

## Explanatory note

The object of this rule is to amend the NSW Admission Board Rules 2015 to increase the fees payable for the services provided by the Board, to add a definition of 'PLT' and to correct an incorrect reference to the Practical Training Exemption Sub-Committee as the 'PLT Sub-Committee' in the Third Schedule.

### 1 Name of Rule

This Rule is the NSW Admission Board Amendment (Fees) Rule 2025.

### 2 Commencement

This Rule commences on 1 July 2025 and is required to be Gazetted and notified on the Legal Profession Admission Board website.

### 3 Amendment of NSW Admission Board Rules 2015

#### (1) Rule 4

- (i) Amend the Rule by adding the heading "**Definitions**" next to the number "4".
- (ii) Insert the following definition after the definition of "Legal Qualifications Committee"

**PLT** means Practical Legal Training
